- 2) While finalising the draft Town Planning Scheme, the Town Planning Officer shall consider to continue Ω.P.No.97 (Block No.218) as road (leke)

- While finalising the draft Town Planning Scheme, the Town Planning Officer shall carve out a seperate original plots of lands declared as surplus under the provisions of the Urban Land Ceiling Act 1976 and allot appropriate final plots in lieu of these original plots.
