

NOTIFICATION

The Bombay
Town Planning
Act, 1954.

No. GH/P/184 of 1976/ TFS/4276-4244-2:-

WHEREAS under Section 22 of the Bombay Town Planning Act, 1954 (Bom. XXVII of 1955) (hereinafter referred to as "the said Act") the Municipal Corporation of Surat Declared its intention of making of the Town Planning Scheme Surat No.11 (Adajan);

AND, WHEREAS under sub-section (1) of Section 23 of the said Act the Municipal Corporation of Surat (hereinafter called " the said Municipal Corporation") prepared and published duly in the prescribed manner a draft scheme (hereinafter called " the said scheme") in respect of the area included in the Town Planning Scheme, Surat No. 11(Adajan);

AND WHEREAS after taking into consideration the objections received by its said Municipal Corporation submitted the said scheme to the State Government for sanction under section 28 of the said Act in the manner provided therein;

AND WHEREAS in exercise of the powers conferred by sub-section (2) of section 28 of the said Act Government has consulted the Consulting Surveyor to Government;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (2) of section 28 of the said Act, Government of Gujarat hereby:-

- (a) Sanctions the said Scheme;
- (b) States that the said scheme shall be kept open to the inspection of the public at the office of the said Municipal Corporation during office hours on all working days.
