WHEREAS under Government Notification, Panchayars
Housing and Urban Development Department No.G 1/1/5
of 1977/TPS-4276/2189(77)-Q dated the 20th April, 1977
the Government of Gujarat had, in exercise of the
powers conferred by sub-section (2) of Section 28 of
the Bombay Town Planning Act, 1954 (Bombay Act No.XXVII
