

AND WHEREAS under Government Notification, Urban Development and Urban Housing Department No.GH/V/103 of 1999/TPS/1498-2272-L dated 30-06-1999 the Government of Gujarat, in exercise of the powers conferred by section 65 of the said Act 1976, sanctioned the Preliminary Town Planning Scheme Surat No.13 (Adajan)

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat the Final Town Planning Scheme Surat No. 13 (Adajan) (hereinafter referred to as " the said Final Scheme ") as required under sub-section (2) of section 52 and section (2) of section 62 of the said Act;

NOW THEREFORE, In exercise of the powers conferred by section 65 of the said Act. the Government of Gujarat hereby:-

- (a) sanctions " the said final Scheme "
- (b) states that the said Final Scheme shall be kept open for inspection by the public at the office of the Surat Municipal Corporation during office hours of all working days;



(c) Fixes the 15-01-2006 as the date for the purpose of clause (b) of subsection (2) of the section 65 of the said Act.
