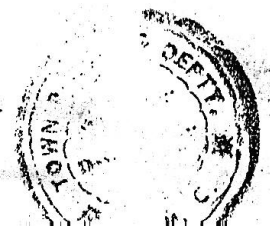

NO.GH/V/40/1994/TPS/1489/713/L:- WHEREAS under Government Notification, Urban Development and Urban Housing Department No.GH/V/8 of 1987/TPS/1486/5115/L dated 5th January, 1987, the Government of Gujarat had in-exercise of the powers conferred by sub-section(2) of Section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") sanctioned a draft Town Planning Scheme, Surat No.16 (Kapadara) (hereinafter referred to as "the said draft scheme") submitted to it by the Surat Municipal Corporation; AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, Government of Gujarat had appointed the Town Planning Officer for the said draft scheme;

AND WHEREAS the Town Planning Officer appointed has submitted to the Government of Gujarat the Town Planning Scheme, Surat No.16 (Kapadara)-Preliminary Scheme (hereinafter referred to as "the said Preliminary scheme") as required under sub-section(2) of section 52 and 64 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976);




NOW THEREFORE in exercise of the powers conferred by Section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) the Government of Gujarat hereby:-

- a) sanctions the "said preliminary scheme" subject to the modifications enumerated in the Schedule appended hereto;
- b) states that the said scheme shall be kept open to inspection by the public at the office of the Surat Municipal Corporation during office hours on all working days except Sundays and holidays, and
- c) fixes 20th October, 1994 as the date for the purpose of clause (b) of sub-section (2) of the said Section-65.

Schedule

1. The Development Control Regulation shall be treated as excluded from the Preliminary Scheme documents.


