WHEREAS under section 41 of the Gujarat Town Planning and Urban Development Act,1976\$ President's Act No.27 of 1976; (hereinafter referred to as " the said Act") the Surat Municipal Corporation declared its intention of making of the Town Planning Scheme, Surat No.46 (Kapadra); AND WHEREAS under sub-section(1) of section 42 of thesaid act, the Surat Municipal Corporation Shereinafter called the "said Municipal Corporation" made and published duly in the Prescribed manner a draft scheme (hereinafter called "the said Scheme") in respect of the area included in the Town Planning Scheme, Surat

- a) sanctions the said scheme subject to the modifications enumberated in the Schedules appeneded hereto, and
- b) states that the said scheme shall be kept open to the inspection of the public at the office of the Surat Municipal Corporation during office hours on all working days;

## Schedule

1p In Redistribution and Valuation Statement the Words

"plots allotted to the Appropriate Local Authority"

Appearing on page No.18 of the Scheme book shall be substitute by the words "plots allotted to Appropriate Authority". Moreover on the same page and on page no.19 in Resistribution and Valuation Statement the Words Surat Municipal Corporation "cocuring in the colu, m no.2 and on page no.18 of the Redistribution and Valuation Statement word "Municipal "occuring in column no.16 against final plot R8; shall each be replaced by the words "Appropriate Authority".

- The works provided in the scheme shall be completed with in the period of \$5 months from the comming into force of the preliminary scheme.
- In view of the provision of Section 40(3)(jj)of the Act, the Town Planning Officer when appointed shall appot more for commercial purpose shall allot more area for commercial purpose by re-appropriating the final plots alloted for public purposes. However, in doing so he shall not reduce themse the area alloted for E.W.S. Housing
- 4. With regard to Estimates of cost of work the Town Planning Officer, when appointed shall appropriately consider the provious of Sec. 77(a),77(b) and 77(g) of the Act.
