AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the finalizing the said Draft Town Planning Scheme ;

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat the Town Planning Scheme Surat No. 18 (Katargam) Preliminary Scheme (hereinafter referred to as " the said Preliminary Scheme ") as required under sub-section (2) of section 52 and section 64 of the said Act.

NOW THEREFORE, in exercise of the powers conferred by section 65 of the said Act, the Government of Gujarat hereby :-

- (a) sanctions " the said Preliminary Scheme " subject to the modification enumerated in the Schedule appended hereto ;
- (b) states that the said preliminary scheme shall be kept open to inspection by the general public at the office of the said Authority, Surat during office hours on working days


