THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976

No. GH/V/313 of 2025/UDUHD/TPS/e-File/18/2023/2985/L: WHEREAS, under Government Notification, Urban Development and Urban Housing Department No. GH/V/147 of 2007/TPS-1406-2128-L, dated 27.04.2007 the Government of Gujarat, in exercise of the powers conferred by section 48(2) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") sanctioned the Draft Town Planning Scheme No. 21 (Sarthana-Simada) (hereinafter referred to as "the said Draft Scheme") submitted by the Surat Urban Development Authority, Surat;

AND WHEREAS, the area of said draft scheme was included within the jurisdiction of Surat Municipal Corporation (hereinafter referred to as "the said Authority") vide notification no. KV/212/2006/SMN902006/410/P, dated.20.07.2006;

AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for finalizing the said Draft Scheme;

AND WHEREAS, the Town Planning Officer has submitted, to the Government of Gujarat, the Preliminary Town Planning Scheme No. 21 (Sarthana-Simada) (hereinafter referred to as "the said Preliminary Scheme") as required under section 52(2) and section 64 of the said Act;

NOW THEREFORE, in exercise of the powers conferred by section-65 of the said Act, the Government of Gujarat hereby: -

- (a) Sanction the said Preliminary Scheme with modifications enumerated in schedule appended hereto;
- (b) State that the said preliminary scheme shall be kept open for the inspection of the public, at the office of the said Authority, during office hours on working days;
- (c) Fix the date of this notification as the date for the purpose of clause (b) of sub-section (2) of the section 65.

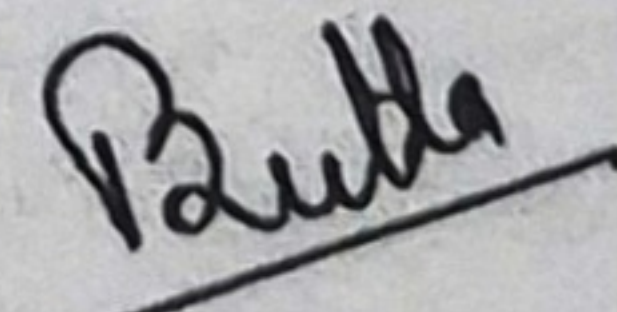
