

THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976.

No.GH/V/*, of 2012/TPS-1409-1344-L: WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/57 of 2000/TPS/1499/1588/L, dated 28.02.2000, the Government of Gujarat, in exercise of the powers conferred by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as " the said Act ") sanctioned the Draft Town Planning Scheme Surat No. 31 (Adajan) (hereinafter referred to as " the said Draft Scheme") submitted by the Surat Municipal Corporation; (hereinafter referred to as " the said Authority ")


AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the finalizing the said Draft Scheme;

AND WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/113 of 2006/TPS/1405/830/L dated 19.04.2006 the Government of Gujarat, in exercise of the powers conferred by section 65 of the said Act 1976, sanctioned the Preliminary Town Planning Scheme Surat No. 31 (Adajan)

AND WHEREAS, the Town Planning Officer submitted, to the Government of Gujarat, the Final Town Planning Scheme Surat No. 31 (Adajan) (hereinafter referred to as " the said Final Scheme ") as required under sub-section (2) of section 52 and section (2) of section 62 of the said Act;

NOW THEREFORE, in exercise of the powers conferred by section 65 of the said Act. the Government of Gujarat hereby :-

(a) Sanction "the said Final Scheme" without modification, and



(b) State that the said Final Scheme shall be kept open for inspection by the public at the office of the Surat Municipal Corporation during office hours of all working days;

Fix the date of this notification as the date for the purpose of clause (b) of sub-section (2) of the section 65 of the said Act.
