THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976

NO.GH/V/ 240 of 2003/TPS-142001-1694-L.- WHEREAS under Government Notification, Urban Development and Urban Housing Department No.GH/V/192 of 1999/TPS-1489/901-2 dated 30/11/1999, the Government of Gujarat had in exercise of the powers conferred by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") sanctioned a Draft Town Planning Scheme Surat No.32 (Adajan), (hereinafter referred to as "the said scheme") submitted to it by the Surat Municipal Corporation, Surat.

AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, Government of Gujarat had appointed the Town Planning Officer for the said draft Town Planning Scheme;

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat the Preliminary Scheme, Surat No.32 (Adajan) (hereinafter referred to as "the said Preliminary Scheme") as required under sub section (2) of section 52 and 64 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976);

NOW THEREFORE in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) the Government of Gujarat hereby:-

- (a) Sanctions the "said preliminary scheme" without modifications.
- (b) States that the said scheme shall be kept open to inspection by the public at the office of the Surat Municipal Corporation, Surat during office hours on all working days.
- (c) fixes 20-01-2004 as the date for purpose of clause (b) of sub-section (2) of the said Section 65.
