NO.GH/ V; 100 Of 2006/TPS-1405-1620-L: WHEREAS, under section 41 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") the Surat Urban Development declared its intention of making of the Draft Town Planning Scheme No. 37 (Variyav) (herein after referred to as "the Said Authority" and "the said Draft Scheme").

AND WHEREAS, under sub section (1) of section 42 of said Act, the Surat Urban Development Authority made and published, duly in the prescribed manner, the said Draft scheme in respect of the area included in the said Draft Scheme.

AND WHEREAS, after taking into consideration of the objections or suggestions received by the said Authority. The said Authority submitted the said Draft Scheme to the State Government for sanction under section 48(1) of the said Act, in the manner provided therein:

NOW THEREFORE, in exercise of the powers conferred by section 48(2) of the said Act. the Government of Gujarat hereby :

- (a) sanctions the said Draft Scheme with modifications enumerated in the Schedule appended here to.
- (b) states that the said Draft Scheme shall be kept open for inspection by the public, at the office of the Surat Urban Development Authority, during office hours on all working days.

SCHEDULE

- (1) While finalizing the said Draft Scheme, the Town Planning Officer shall carve out separate Original Plots of lands declared as surplus under the provision of the Urban Lands, (Ceiling and Regulation) Act, 1976, and shall allot appropriate separate Final Plots in lieu of these Original Plots.
- (2) While finalizing the said-Draft Scheme, the Town Planning Officer shall deduct the lands, at par, with average deduction of lands as far as possible.

- (3) While finalizing the said Draft Scheme, the Town Planning Officer s allot F.P.s in their O.P.s or near by as far as possible.
- (6) The General Development Control Regulations, Zonings Reservations of the sanctioned Revised Development Plan of St Urban Development Authority, as modified from time to time, shall applicable for the said Draft Scheme.
- (7) While finalizing the said Draft Scheme, the Town Planning Officer s take decision to increase area for allotment for SEV/SHS, up to 5 % of scheme area.
- (9) While finalizing the said Draft Scheme, the Town Planning Officer's carve out the Final Plots in regular shapes and buildable as per provisions of the G.D.C.R.
- (10) While finalizing the said Draft Scheme, the Town Planning Officer s not deduct lands of talay and other lands of water bodies.
- (11) While finalizing the said Draft Scheme, the Town Planning Officer shadecide the ownerships, areas and tenures as per the revenue records
- (12) While finalizing the said Draft Scheme, the Town Planning Officer s give only one Sr.No. or Case No. instead of Sr. No. 76 to 102 Redistribution and Valuation Statement.
- (14) While finalizing the said Draft Scheme, the Town Planning Officer's consider expenditure incurred by the appropriate Authority, unsection 52(1)(iv), 77(1)(b) and 77(1)(g) of the said Act.
- (15) In the said Draft Scheme in form "F" alloted for the final plots reser for public Appropriate Authority shall be shown as Appropr Authority, Surat Urban Development Authority.
- (16) While finalizing the said Draft Scheme, the Town Planning Officer's decide the percentage of the beneficiaries to residents of the sche area and to general public, in consultation with the appropria authority and Chief Town Planner, in accordance with the provision: said Act.
