THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976.

NO.GH/ V/ 100 Of 2006/TPS-1405-1620-L : WHEREAS, under section 41 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") the Surat Urban Development declared its intention of making of the Draft Town Planning Scheme No. 37 (Variyav) (herein after referred to as "the Said Authority" and "the said Draft Scheme").

AND WHEREAS, under sub section (1) of section 42 of said Act, the Surat Urban Development Authority made and published, duly in the prescribed manner, the said Draft scheme in respect of the area included in the said Draft Scheme.

AND WHEREAS, after taking into consideration of the objections or suggestions received by the said Authority. The said Authority submitted the said Draft Scheme to the State Government for sanction under section 48(1) of the said Act, in the manner provided therein;

NOW THEREFORE, in exercise of the powers conferred by section 48(2) of the said Act, the Government of Gujarat hereby :


- (a) sanctions the said Draft Scheme with modifications enumerated in the Schedule appended here to.
- (b) states that the said Draft Scheme shall be kept open for inspection by the public, at the office of the Surat Urban Development Authority, during office hours on all working days.

SCHEDULE

- (1) While finalizing the said Draft Scheme, the Town Planning Officer shall carve out separate Original Plots of lands declared as surplus under the provision of the Urban Lands, (Ceiling and Regulation) Act, 1976, and shall allot appropriate separate Final Plots in lieu of these Original Plots.
- (2) While finalizing the said Draft Scheme, the Town Planning Officer shall deduct the lands, at par, with average deduction of lands as far as possible.

- (3) While finalizing the said Draft Scheme, the Town Planning Officer shall allot F.P.s in their O.P.s or near by as far as possible.
- (6) The General Development Control Regulations, Zonings Reservations of the sanctioned Revised Development Plan of Surat Urban Development Authority, as modified from time to time, shall be applicable for the said Draft Scheme.
- (7) While finalizing the said Draft Scheme, the Town Planning Officer shall take decision to increase area for allotment for SEWS-MS, up to 5 % of scheme area.
- (9) While finalizing the said Draft Scheme, the Town Planning Officer shall carve out the Final Plots in regular shapes and buildable as per provisions of the G.D.C.R.
- (10) While finalizing the said Draft Scheme, the Town Planning Officer shall not deduct lands of talav and other lands of water bodies.
- (11) While finalizing the said Draft Scheme, the Town Planning Officer shall decide the ownerships, areas and tenures as per the revenue records.
- (12) While finalizing the said Draft Scheme, the Town Planning Officer shall give only one Sr.No. or Case No. instead of Sr. No. 76 to 102 Redistribution and Valuation Statement.
- (14) While finalizing the said Draft Scheme, the Town Planning Officer shall consider expenditure incurred by the appropriate Authority, under section 52(1)(iv), 77(1)(b) and 77(1)(g) of the said Act.
- (15) In the said Draft Scheme in form " F " allotted for the final plots reserved for public Appropriate Authority shall be shown as Appropriate Authority, Surat Urban Development Authority.
- (16) While finalizing the said Draft Scheme, the Town Planning Officer shall decide the percentage of the beneficiaries to residents of the scheme area and to general public, in consultation with the appropriate authority and Chief Town Planner, in accordance with the provisions of the said Act.
