No.GH/V/ 381 of 2024/UDUHD/TPS/e-file/18/2024/0133/L: WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/247 of 2006-TPS-1406-610-L, dated 04.09.2006 the Government of Gujarat, in exercise of the powers conferred by section 48(2) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") sanctioned the Draft Town Planning Scheme No.54 (Bhestan) (hereinafter referred to as "the said Draft Scheme") submitted by the Surat Municipal Corporation (hereinafter referred to as "the said Authority").
