NOW THEREFORE, in exercise of the powers conferred by section 48(2) of the said Act. the Government of Gujarat hereby :-

- (b) state that the said Draft Scheme shall be kept open for inspection by the public, at the office of the said Authority, during office hours on all working days.

- Allot separate O.P./F.P. for excess lands declare under U.L.C. Act.
- Replace the word "List of plots allotted to appropriate authority under section 40(3)" by "Final plots allotted to Surat Municipal Corporation" in the Redistribution and Valuation Statement (Form-F).
- Estimate and include cost of scheme borne by appropriate Authority, under section 52(1)(iv), 77(1)(b) and 77(1)(g) of the said Act as well as determine the period within which the works provided in the scheme shall be completed by the appropriate authority.
- Carve out the final plots in regular shapes, useable and buildable as per the provisions of the G.D.C.R. (Final plot no.R-6, R-29, 30, 121/D, 121/A, 123/B, 10/A, 61, 62, 60, 59, 63, 37, 20, 15)
- Verify and correct the name of owner, area, tenure, etc as per revenue record (area of O.P. No. 114 and Block No. 178/p, 179/p, 180/p, 181/p, 220/p, 279/p, 280/p, 281/p, 282/A/p, 283/1/p, 282/2/p, 290/p, 291/p, 292/p, 336/p, 426/p etc. and tenure for case no. 56, 59, 60, 61, 62 etc.)

- Increase the area for SEWSHS up to 5% of the Scheme area.
- Decide the various road proposals, considering width and alignment of

 wide road proposal which is not permissible as per the provision of
 GDCR.
