This guarantee is issued subject to the conditions that the liability of the Bank under this guarantee is limited to a maximum of Rs. 5,00,000/- (Rupees Five Lacs only) and the guarantee shall remain in full **force up to** ____/02/2027, and can not be invoked other than by a written demand for claim this guarantee served on the Bank on or **before the** ____/02/2027.

Whereas **Mr.** _____, **S/o Mr.** _____, has been selected for the admission to M.B.B.S. Course in SMIMER Medical College, Surat (Gujarat) and for this matter the Government of Gujarat (herein after called as the Govt.) has decided to prescribe conditions for admission to Surat Municipal Institute of Medical Education & Research (SMIMER), Opp. Bombay Market, Umarwada, Surat – 395010, India and for the Govt of Gujarat (hereinafter called as the Govt.) has decided for prescribe a condition for admission to Government medical college for said Course from that the College or from any other College in the state and that on such completion he/she shall is so required by the

Government in any other rural areas of the state from minimum period of One (1) year service in any of the tribal areas of state on such prescribed thereof and shall furnish suitable bond for the due performance of the said conditions.

AND WHEREAS the student who has applied for admission for the said course in Surat Municipal Institute of Medical Education & Research (SMIMER), Opp. Bombay Market, Umarwada, Surat – 395010, India (hereinafter referred to us “THE SAID COLLEGE” has admitted for the said the course,

NOW THE CONDITIONS OF THE ABOVE the written obligation is that is the student shall:-

1. Diligently prosecute and complete the said course at the college or any other medical college in the Surat Municipal Institute of Medical Education & Research (SMIMER) and pass the prescribed University Examination for the said course and
2. Within a period of the Thirty (30) days of the date of her/his completing the period of internship of rotating housemanship, give to the Government by registered post notice in writing intimating the completion of his/her period of internship of rotating housemanship provide however that if the student is desirous of continuing post graduate studies, such notice shall expressly specify such desire and request studies and it shall be open to the Government in is absolute discretion to refuse such permission or to grant it subject to the completions that the condition that the student shall within one (1) month from the completion of **post graduate** course give a like notice to the Government and
3. When called upon by the Government at any time within a period of 6 (Six) months from the receipt of the notice from the student as aforesaid join the state services and service in any of the rural areas of the state for minimum period of One (1) year at such remuneration as may be prescribed thereof and in the event of the student not being so called upon by the Government to join the state service and serve them for agreed period of One (1) year in any of the rural areas of the state and during the student is required to serve the under the provision of the Bank Guarantee faithfully discharge the duties assigned to him/her by the Government or his/her order superiors with utmost diligence and efficiency and shall observe the rules for time being in force regulating

the conduct of persons of serving.

4. Then the above written Bank Guarantee shall become Void otherwise the same shall remain in full force and virtue.

And in the event of student committing a breach of any of the above terms and conditions the whole amount Rs. 5,00,000/- (Rupees Five Lacs only) or other such lesser sum as the Government may in its discretion shall become payable by _____ BANK LTD, _____, and the Surat Municipal Institute of Medical Education & Research (SMIMER) may without prejudice to any other rights and remedied of the Surat Municipal Institute of Medical Education & Research (SMIMER) recover from the student.

And upon making of such payment the above return obligation shall be void and not effect. Otherwise it shall be remain in full force and virtue.

Provided always and it is hereby agreed and declared that the decision of the Surat Municipal Institute of Medical Education & Research (SMIMER) and whether the same student has or has not performed and observed by the obligation and condition herein before recited and amount of compensation payable in this behalf shall be final and binding on the parties hereto.
