Subject: Veer Narmad South Gujarat University - Renewal of recognition of MS(OBG) qualification for 02 seats in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 29.05.2018 considered the Council Assessor's Report (24.04.2018) on the standard of examination and other teaching facilities available for Renewal of recognition of MS(OBG) qualification for 02 seats in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat granted by Veer Narmad South Gujarat University. The Committee decided as under:-

*The Postgraduate Medical Education Committee considered the Council Assessor's Report (24.04.2018) and decided to recommend to the Central Government that the recognition of MS(OBG) qualification for 02 seats granted by Veer Narmad South Gujarat University in respect of students being trained at Surat Municipal Institute of Medical Education & Research, Surat be renewed.*  
*The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.*

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 12.06.2018.
