Sub: Increase of seats in MD(Pathology) course at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujarat University, Surat u/s 26(1)(a)(b) and 28(1) (2) of the NMC Act, 2019 for the academic year 2021-2022 - Permission of Medical Assessment and Rating Board - Regarding.

Sir/Madam,

I am directed to refer your proposal for Increase of seats in MD(Pathology) course at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujarat University, Surat at Surat Municipal Institute of Medical Education & Research, Surat u/s 26(1)(a)(b) and 28(1) (2) of the NMC Act, 2019 for the academic year 2021-2022.

It is to inform that the Medical Assessment Rating Board (MARB) of National Medical Commission (NMC) considered the Assessor's report (17/04/2021) together with the recommendations of the PG Expert Group on the physical and other teaching facilities available at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujarat University, Surat Increase of seats in MD(Pathology) course u/s 26(1)(a)(b) and 28(1) (2) of the NMC Act, 2019 for the academic year 2021-2022 and decided as under:

"The Medical Assessment and Rating Board (MARB) considered the Assessor's Report 17/04/2021 together with recommendations of the PG Expert Group and decided to issue Letter of Permission for Increase of seats in MD(Pathology) course at Surat Municipal Institute of Medical Education & Research, Surat under Veer Narmad South Gujarat University, Surat u/s 26(1)(a)(b) and 28(1) (2) of the NMC Act, 2019 prospectively i.e. from the academic session 2021-22 for 04 to 10 (Seats) per year till the first batch admitted against the approved number, appears in the final examination of the said course. The Teaching Institution is advised to apply for recognition of the qualification for the approved intake at the time of first available exit/final examination as per the provision of Section 11(2) of the IMC Act, 1956."

It is also to inform that the Medical Assessment and Rating Board (MARB) further decided that Letter of Permission for Increase of seats in MD(Pathology) course for 04 to 10 (Seats) as per available facilities with prospective effect i.e. for the academic session 2021-22 at Surat Municipal Institute of Medical Education & Research, Surat u/s 26(1)(a)(b) and 28(1) (2) of the NMC Act, 2019 may be issued.

In view of the above decision, the Council had decided to obtain undertaking/ essential document for issue of Letter of Permission for starting/increase in seats for the academic year 2021-22 :-

1. The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipment and hospital facilities as per National Medical Commission norms. It is further requested to you, to give an undertaking that any other courses (Fellowships/DNB) being run in the concerned speciality, may be discontinued.
2. No student should be admitted in the above courses till the formal permission of the Medical Assessment and Rating Board (MARB).
